Kodiak Capital Group Launches Tactical Cannabis Opportunity Fund

Fund will invest in publicly-traded cannabis companies and provide acquisition capital to existing portfolio

NNEWPORT BEACH, CA--Kodiak Capital Group, LLC ("Kodiak"), the leading fund manager for venture investments into publicly traded cannabis companies, has introduced its new Tactical Cannabis Opportunity Fund to prospective partners. The fund was launched to meet the needs of public companies in the cannabis space that are seeking growth capital.

The focus of Kodiak's Tactical Cannabis Opportunity Fund is to make principal, non-control, debt or equity investments ranging from \$500,000 to \$2,000,000 in North American publicly-traded cannabis companies. Kodiak has made 38 investments in early-stage cannabis companies and currently has a portfolio of 21 public cannabis companies that they are assisting with growth and acquisition strategies.

In 2016 alone, Kodiak committed over \$25 million to 17 publicly-traded cannabis companies.

"As the leading institutional investor in the public North American cannabis space, we are extremely pleased to introduce our new Tactical Cannabis Opportunity Fund," said Managing Member Ryan Hodson. "Our intention is to begin deploying capital from the fund as soon as possible. We have already begun discussing investments with a variety of interested companies."

"We expect cannabis deal flow to be robust in 2017, especially as public acceptance of the industry - which was recently projected by Forbes to grow 700% by 2020 - continues to increase." Hodson added.

Kodiak's Investment Criteria:

At Kodiak, we devote extensive resources to performing the primary research and due diligence needed to identify companies that fit our investment profile. Our team works closely with lawyers, accountants, and consultants to develop a complete understanding of each transaction.

Financial Criteria

Kodiak generally invests in platform companies with greater than \$5 million of revenue, and our target investment size is \$1 to \$25 million. However, we will consider, and have made, investments in companies with lower revenue that are rapidly growing or have add-on acquisition opportunities.

Transaction Criteria

Kodiak focuses on investments in companies in the following industries: consumer products, life sciences, natural resources and social media technology.

Kodiak focuses on investments in companies which exhibit revenue potential driven by compelling economic, demographic, or industry growth trends.

Kodiak invests in businesses with intangible value which provides a source of sustainable competitive advantage and creates barriers to entry. Examples of such intangibles include brands or systems.

Management Criteria

Kodiak seeks companies with management teams whose character, culture, and organization are conducive to forming true, long-term partnerships. We work closely with management and generally invest together, developing relationships that frequently outlast any single investment. We seek to align our interests with management both economically and strategically.
